How to Use

WASHING

Wash & dry udder and teats before milking.

TEAT DIPPING:

Fill teat cup about 3/3 full. No dilution is required. Dip teats of every cow immediately after each has been milked, making sure that the full length of the teat is immersed. Top up with fresh solution as required. Empty & wash out cups after milking.

TEAT SPRAYING:

Immediately after milking, spray the entire surface of each teat of every cow.

UDDER WASHING & CLUSTER DIPPING

Dilute 1:67. To help prevent cross infection, individual cloths or disposable paper towels are strongly recommended. Dry teats before milking. Immerse clusters & agitate for at least half a minute. Rinse in clean water before use.

Contains a blend of Chlorhexidine Gluconate, Sorbitol, Nonionic Surfactant, Isopropyl Alcohol & Dve.
